**Work with Census** This link allows the user to enter participant data. The data may be manually entered, uploaded or imported from the current census in the Administration System.

- To enter participants via a spreadsheet, click to "Download" the grid (from the screen shown at right). Open the file and enter your data. Then click to "Upload" and browse for the file.
- If you are using the admin system for this plan, you can simply click to "Copy Census From Admin (Then Click 'Refresh')". As the button indicates, you must click to "Refresh the Grid" once you have copied the census (link located above the copy button). You will then see names and information copied over from the most recent year in the Admin system. This data can be further modified for purposes of the proposal system.
- To manually enter a participant, type in the employee number, first name and last name and click "Add Participant".

The "Pref" (Preferred) column (between 'HCE' and 'Comp') indicates if the participant will be separately report in the preferred section of the report. At least one preferred participant should be selected.

**Hint!** To have the system calculate HCE and Key status, we suggest uploading the census data into the Administration System and running the data scrub. Then return to the proposal screen and 'Copy Census from Admin'.

**Note:** All participants in the census on the proposal system are assumed to be eligible for all sources.

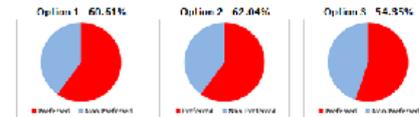
